TERMS

1. All prices are in Malaysian Ringgit. This schedule applies uniformly to every firm and is not varied per client.
2. Fees are set against the cost they displace, and every module is counsel-reviewed as standard; no module ships un-reviewed, and no review is sold as an upgrade.
3. The RM1,000 reserve secures a build slot and the scoping sitting, and is credited in full against the setup fee; the RM2,500 balance is payable only at launch, once the build is live.
4. Every assistant tier includes three practice areas, Malay and English, hosting, support, and content kept current. Monthly fees are cancellable on 30 days' written notice.
5. Counsel-reviewed language is a terminology and clarity review against Malaysian legal usage. It is not legal advice, creates no solicitor-client relationship, and the firm remains responsible for content published under its name.
